4 ORDINANCE NO. 18582

6 AN ORDINANCE introduced by Councilmembers Jeff Preisner, Richard Harmon, John  
7 Alcalá, Clark Duffy, Sylvia Ortiz, Lana Kennedy, John Nave, and Bill  
8 Haynes authorizing the St. Patrick's Day Committee to hold the St.  
9 Patrick's Day Street Fair on March 17, 2006.

11 WHEREAS, the St Patrick's Day Committee is a committee of private citizens who  
12 organize, plan, and promote St Patrick's Day events that are celebrated in Topeka's unique  
13 historic downtown district.

14 NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF  
15 TOPEKA, KANSAS:

16 Section 1. Authorization is hereby given to the St. Patrick's Day Committee to  
17 hold the St. Patrick's Day Street Fair on 8<sup>th</sup> Street between Kansas Avenue and Jackson  
18 Street on March 17, 2006.

19 Authorization also is given to barricade 8<sup>th</sup> Street between Kansas Avenue and  
20 Jackson Street between the hours of 8:00 a.m. and 6:00 p.m. Attendance to the St.  
21 Patrick's Day Street Fair is open to the public between the hours of 10:00 a.m. and 6:00  
22 p.m. on March 17, 2006. Licensed retailers which are authorized by the St. Patrick's Day  
23 Committee may sell cereal malt beverages, non-alcoholic commodities or food between the  
24 hours of 10:00 a.m. and 6:00 p.m. on March 17, 2006. Event attendees may buy, possess  
25 and consume cereal malt beverages on the barricaded portion of 8<sup>th</sup> Street between the  
26 hours of 10:00 a.m. and 6:00 p.m. on March 17, 2006. Any person holding the appropriate  
27 license to sell cereal malt beverages may in accordance with all applicable state laws and

28 municipal ordinances sell cereal malt beverages in the barricaded portion of 8<sup>th</sup> Street  
29 between the hours of 10:00 a.m. and 6:00 p.m. on March 17, 2006.

30 Section 2. This Ordinance shall be null and void on March 18, 2006.

31 Section 3. This Ordinance shall take effect and be in force after its passage,  
32 approval and publication in the official city newspaper.
