4 ORDINANCE NO. 18608

6 AN ORDINANCE introduced by City Manager Norton N. Bonaparte, Jr., authorizing an  
7 amendment to the project budget for Project No. 30127, Phase 7,  
8 which provides for design and construction of an extension of the  
9 existing Shunga bicycle and jogging trail from the intersection of  
10 Topeka Boulevard and Shunga Creek proceeding north and east  
11 following Shunga Creek for a distance of approximately 2700 feet as  
12 more specifically described herein, all pursuant to Section A12-1 of  
13 the Code of the City of Topeka, and specifically repealing City of  
14 Topeka Ordinance Nos. 17686 and 17526.  
15

16 BE IT ORDAINED BY THE COUNCIL OF THE CITY OF TOPEKA, KANSAS:  
17

18 Section 1. That it is hereby deemed advisable and necessary and is also hereby  
19 authorized, pursuant to Section A12-1 of the Code of the City of Topeka that the following  
20 public improvement be made:

21 A. GENERAL NATURE OF IMPROVEMENT:  
22

23 The development of plans and specifications to extend the existing Shunga  
24 bicycle and jogging trail from Topeka Boulevard north and east to the  
25 abandoned Missouri-Pacific Railroad Right of Way. This project includes  
26 construction of a 10-foot wide concrete sidewalk passing under Topeka  
27 Boulevard.

42 specifically repealed.

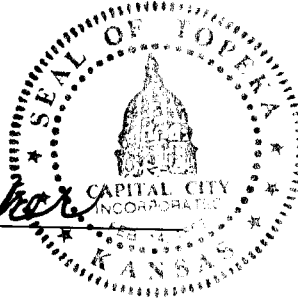
43            Section 3.    This Ordinance shall take effect and be in force from and after its
