5 AN ORDINANCE introduced by City Manager, Norton N. Bonaparte, Jr., instituting a
6 real estate lien upon certain lots and pieces of ground in Shawnee
7 County, Kansas, to pay the cost for sewage collection and
8 treatment where such payments to the City have not been made
9 due to neglect, failure or refusal to pay, pursuant to K.S.A. 12-631k.

11 BE IT ORDAINED BY THE COUNCIL OF THE CITY OF TOPEKA, KANSAS:

13 Section 1. That there be and is hereby instituted a real estate lien upon the
14 following described lots and pieces of ground in Shawnee County, Kansas, pursuant to

18 same to the County Clerk of Shawnee County, Kansas, who shall place the several

19 amounts mentioned in Section 1 of this Ordinance upon the tax rolls of said County to

20 be collected as one (1) tax in the same manner as other taxes and assessments are

21 collected.

22 Section 3. This Ordinance shall take effect and be in force from and after its

23 passage, approval and publication in the official City newspaper.
