4 **ORDINANCE NO. 18912**

6 AN ORDINANCE introduced by Councilmember John Alcalá, removing certain portions
7 of NE Atchison Avenue and NE Chandler Street from the right-of-way
8 to allow the sale, consumption and possession of alcoholic liquor as
9 part of the Fiesta Mexicana, at specified locations and times.
10

11 WHEREAS, the organizers of the Fiesta Mexicana desire to allow for the sale,
12 possession and consumption of alcoholic liquor in portions of NE Atchison Avenue and NE
13 Chandler Street as part of the Fiesta Mexicana.

14 NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF
15 TOPEKA, KANSAS:

16 Section 1. Authorization is given to barricade a portion of the right-of-way on NE
17 Atchison Avenue between Chandler and Lake Streets and NE Chandler Street between
18 Greeley Street and Atchison Avenue, between the hours of 4:00 p.m. and 12:00 midnight
19 from July 17, 2007 through July 21, 2007. The barricaded portions of NE Atchison Avenue
20 and NE Chandler Street between the hours of 4:00 p.m. and 12:00 midnight from July 17,
21 2007 through July 21, 2007, shall be temporarily removed from the City's right-of-way and
22 the provisions of K.S.A. 41-719. Alcoholic liquor may be sold, possessed and consumed in
23 the barricaded portions of NE Atchison Avenue and NE Chandler Street between the hours
24 of 4:00 p.m. and 12:00 midnight from July 17, 2007 through July 21, 2007, provided the
25 vendor holds the appropriate license from the State of Kansas to sell alcoholic liquor in
26 accordance with all applicable state laws and municipal ordinances. Event attendees may
27 buy, possess and consume alcoholic beverages in the barricaded portions of NE Atchison
28 Avenue and NE Chandler Street between the hours of 4:00 p.m. and 12:00 midnight from

29 July 17, 2007 through July 21, 2007, in accordance with all applicable state laws and
30 municipal ordinances.

31 Section 2. This Ordinance shall be null and void on July 22, 2007.

32 Section 3. This Ordinance shall take effect and be in force after its passage,
33 approval and publication in the official city newspaper.
