3 **ORDINANCE NO. 19454**
4

5 AN ORDINANCE introduced by City Manager Norton N. Bonaparte, Jr., amending the
6 project budget and authorizing as amended Improvement Project No.
7 T-301005.00 (HTE #302840) which provides for extension of Landon
8 Trail, as more specifically described herein, pursuant to Section A12-1
9 of the Code of the City of Topeka, and repealing City of Topeka
10 Ordinance No. 19354.

12 WHEREAS, the City of Topeka adopted Ordinance No. 19354, effective on January
13 18, 2010, which authorized Improvement Project No. T-301005.00 (HTE #302840) for
14 improvements to Landon Trail. The project was to extend the trail to SE 32nd Street with a
15 project budget of five hundred twenty-nine thousand six hundred dollars (\$529,600.00) of
16 General Obligation Bonds and other lawfully available funds; and

17 WHEREAS, it is necessary to amend the project budget to provide for the use of
18 additional federal funds to extend the trail further to approximately SE 49th Street.

19 NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE
20 CITY OF TOPEKA:

21 Section 1. That it hereby deems advisable and necessary Improvement Project
22 No. T-301005.00 (HTE #302840) and also hereby authorizes, pursuant to Section A12-1 of
23 the Code of the City of Topeka, that the public improvement be made as follows:

24 A. GENERAL NATURE OF IMPROVEMENT:
25

26 This project will extend the existing Landon Trail along the railroad right-of-
27 way, beginning at SE 25th Street, just east of Kansas Avenue and progress to
28 the south along the Missouri-Pacific Railroad tracks to approximately SE 49th
29 Street. The trail will be 10 feet wide and will be concrete with graded
30 shoulders. The sub-base will be the existing railroad ballast. The project will
31 also include drainage enhancements, at-grade street crossings, bridge
32 improvements and all related appurtenances needed for a complete project.
