4 RESOLUTION OF ADVISABILITY AND AUTHORIZATION NO. 7097

7 A RESOLUTION introduced by Mayor Joan Wagnon authorizing Street  
8 Improvement Project No. 60563-H, Phase I located on S.E.  
9 27<sup>th</sup> Street and Flora Court as more specifically described  
10 herein.

12 WHEREAS, the City Council has received a petition, pursuant to K.S.A. 12-6a04,  
13 containing the signatures of the owners of 100% of the area in the improvement district  
14 hereinafter described; and

15 WHEREAS, seven (7) days have elapsed since the filing of said petition.

16 NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Topeka,  
17 Kansas, that it finds Street Improvement Project No. 60563-H, Phase I hereinafter  
18 described, to be advisable and does hereby authorize and order said improvement to be  
19 made in accordance with its findings as follows:

20 A. GENERAL NATURE OF IMPROVEMENT:

21 To Pave:

23 S.E. 27<sup>th</sup> Street from the east line of Scorpio Avenue to the east line of Lot  
24 12, Block "A" of Abbey's Grove Subdivision and Flora Court from the north  
25 line of S.E. 27<sup>th</sup> Street north to the north end of the cul-de-sac with asphalt  
26 pavement, concrete curb and gutter, sidewalk ramps, storm drainage  
27 facilities, engineering and all other contingencies needed to complete the  
28 project.

31 B. PROPOSED IMPROVEMENT DISTRICT:

32 Lots 1 through 12, in Block "A", of Abbey's Grove Subdivision,  
33 Topeka, Shawnee County, Kansas
