5 A RESOLUTION introduced by Mayor Joan Wagnon authorizing  
6 Lateral Sanitary Sewer Improvement Project No.  
7 40595-02 located at approximately south and  
8 west of the intersection of S.E. Highland Avenue  
9 and S.E. Gilmore as more specifically described  
10 herein.

12 WHEREAS, the City Council has received a petition, pursuant to  
13 K.S.A. 12-6a04, containing the signature of the owner of 100% of the area  
14 in the improvement district hereinafter described; and

15 WHEREAS, seven (7) days have elapsed since the filing of said  
16 petition.

17 NOW, THEREFORE, BE IT RESOLVED by the Council of the City of  
18 Topeka, Kansas, that it finds Lateral Sanitary Sewer Improvement Project  
19 No. 40595-02, hereinafter described, to be advisable and does hereby  
20 authorize and order said improvement to be made in accordance with its  
21 findings as follows:

23 A. GENERAL NATURE OF IMPROVEMENT:

24 To provide sanitary sewer service to the following described  
25 area with piping, manholes, and all other contingencies  
26 required for a complete project.

On a unit basis for the single lot, which makes up the improvement district.

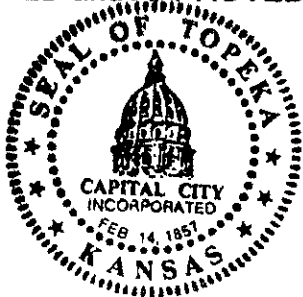
E. APPORTIONMENT OF COSTS:
