4 RESOLUTION OF ADVISABILITY AND AUTHORIZATION NO. 7141

7 A RESOLUTION introduced by Mayor Joan Wagnon authorizing the relocation  
8 of sanitary sewer improvements located in Lateral Sanitary  
9 Sewer District No. 40585, Phase 4, as more specifically  
10 described herein.  
11

12 WHEREAS, the City Council has received a petition, pursuant to K.S.A. 12-6a04,  
13 containing the signatures of the owners of 100% of the area in the improvement district  
14 hereinafter described; and

15 WHEREAS, seven (7) days have elapsed since the filing of said petition.

16 NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Topeka,  
17 Kansas, that it finds the relocation of sanitary sewer improvements located in Lateral  
18 Sanitary Sewer District No. 40585, Phase 4, hereinafter described, to be advisable and  
19 does hereby authorize and order said improvement to be made in accordance with its  
20 findings as follows:

21 A. GENERAL NATURE OF IMPROVEMENT:  
22

23 To relocate the sanitary sewer service west of the existing building  
24 structures. The project provides for piping, manholes, engineering and all  
25 other contingencies required for a complete project.

27 B. PROPOSED IMPROVEMENT DISTRICT:  
28

29 Lot 12, Block "O", Shawnee Lake Subdivision "C" known as 2432 SE  
30 Eveningtide Way.
