7 A RESOLUTION introduced by Mayor Felker, establishing a date for a public hearing
8 concerning the adoption of an amended plan pursuant to the
9 Neighborhood Revitalization Act, K.S.A. (2000 Supp.) 12-17,114 *et*

12 WHEREAS, the City of Topeka, Kansas, has pursuant to K.S.A. (2000 Supp.) 12-
13 17,114 *et seq.*, adopted a plan to assist in the rehabilitation, conservation or
14 redevelopment of any area within the City of Topeka which meets the conditions provided
15 in said law; and

16 WHEREAS, the City of Topeka is desirous of amending said plan in order to
17 rehabilitate, conserve or redevelop certain designated areas in the City of Topeka.

18 NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Topeka,
19 Kansas, in accordance with K.S.A. (2000 Supp.) 12-17,114 *et seq.* the following notice is
20 hereby given:

22 The City Council will consider an amendment to the adopted Neighborhood
23 Revitalization Plan, pursuant to K.S.A. (2000 Supp.) 12-17,114 *et seq.*, at a public hearing
24 at 7:00 p.m. on June 5, 2001, in the City Council Chambers, 214 E. 8th Street,
25 Topeka, Kansas.

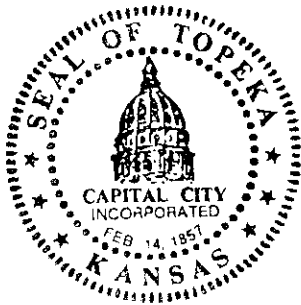
26 The proposed amended Neighborhood Revitalization Plan and a description of the
27 boundaries of the proposed amended Neighborhood Revitalization Area are available for
28 inspection during the hours of 8:00 a.m. to 5:00 p.m. in the office of City Clerk, Room 166,
29 215 E. 7th Street, Topeka, Kansas.

30 At the conclusion of the hearing, the Council of the City of Topeka will consider
31 findings necessary for the adoption of the proposed amended Neighborhood Revitalization
32 Plan.


33 BE IT FURTHER RESOLVED that the City Clerk shall cause a copy of this
