4 RESOLUTION OF ADVISABILITY AND AUTHORIZATION NO. 7158

7 A RESOLUTION introduced by Mayor Felker authorizing the Street Improvement Project
8 No. 60543, Phase II located at SW 40th Street and Gage as more
9 specifically described herein.
10

11 WHEREAS, the City Council has received a petition, pursuant to K.S.A. 12-6a01,
12 containing the signatures of the owners of 100% of the area in the improvement district
13 hereinafter described; and

14 WHEREAS, seven (7) days have elapsed since the filing of said petition.

15 NOW, THEREFORE, BE IT RESOLVED, by the Council of the City of Topeka,
16 Kansas that the Street Improvement Project No. 60543, Phase II located at SW 40th Street
17 and Gage, hereinafter described, to be advisable and does hereby authorize and order
18 said improvement to be made in accordance with its findings as follows:

19 A. GENERAL NATURE OF IMPROVEMENT:

20 To pave SW 40th Street from the north line of Lot 6, Block "D", Colly Creek
21 Subdivision No. 3 southeasterly for a distance of approximately 45 feet.
22 Paving will be 39 feet back to back of curbs. The improvement will include
23 concrete curb and gutter, asphalt pavement, and all other contingencies
24 needed to complete the project.

26 B. PROPOSED IMPROVEMENT DISTRICT:

27 North 45 feet of Lot 6, Block "D", Colly Creek Subdivision No. 3, City of
28 Topeka, Shawnee County, Kansas.

On a square foot of area basis for the lot or parcel which is included in the improvement district.

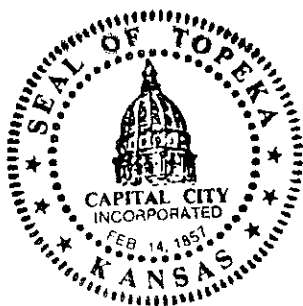
E. APPORTIONMENT OF COSTS:
