

RESOLUTION NO. 719.5

A RESOLUTION introduced by Mayor Felker, relating to Waterworks Project No. 28485 for water line replacement and authorizing the same.

BE IT RESOLVED, by the Council of the City of Topeka, Kansas that it finds the following described public improvement to be necessary and in the public interest and does hereby authorize Waterworks Project. No. 28485 as hereinafter described:

A. GENERAL NATURE OF IMPROVEMENT:

Waterworks Project No. 28485 (2002 Water Main Replacement) calls for the replacement of deteriorating water lines at the following locations:

Mifflin Road – West Drive to 10th Avenue

Grand Court – 6th Avenue to 8th Avenue

Munson Avenue – Seabrook Avenue to Gage Boulevard

Sena Drive – Hillsdale Street to Gage Boulevard

Mission Avenue – 12th Street to north of Munson Avenue

Saline Street – 8th Avenue to 10th Avenue

Watson Avenue – 8th Avenue to 10th Avenue

Shadow Lane – Pembroke Lane to Oakley Avenue

Collins Avenue – Huntoon Street to 15th Street

Huntoon Street – Collins Avenue to Randolph Avenue

Lee Court – Collins Avenue to Randolph Avenue

13th Street – Collins Avenue to Randolph Avenue

Harland Court – Collins Avenue to Randolph Avenue

Plass Avenue – 8th Avenue to 10th Avenue

Hazelton Court – MacVicar Avenue to Summit Avenue
