4 A RESOLUTION introduced by Mayor Felker, establishing a water main connection  
5 charge for extension along SE Quincy Street from SE 40<sup>th</sup> Street to  
6 SE Evans Drive.

8 WHEREAS, the City of Topeka Code Section 146-29 provides for the establishment  
9 of a water main connection charge in order to recoup the expense of a water main  
10 extension; and

11 WHEREAS, the Council of the City of Topeka desires to establish such a charge in  
12 order to recoup the expense of a water main extension along SE Quincy Street from SE  
13 40<sup>th</sup> Street to SE Evans Drive.

14 NOW, THEREFORE, BE IT RESOLVED, by the Council of the City of Topeka,  
15 Kansas that a water main connection charge is hereby established as follows:

16 Location:

17 On SE Quincy Street from SE Evans Drive to SE 40<sup>th</sup> Street. The property on the  
18 east side being Lots 2 through 16, Block G, Southern Hills Subdivision B. The  
19 property on the west side being Lots 11, 12, and 13, Block F, Southern Hills  
20 Subdivision A and Lots 2, 3, 4, 5, and 6, Southern Hills Subdivision C.

21 Method of Financing:

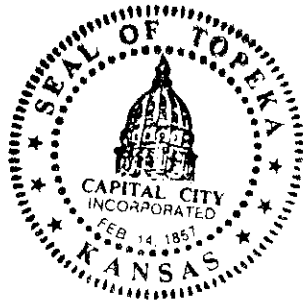
22 The cost of installation of the water main on the East side of SE Quincy Street being  
23 Lots 2, 3, 4, and 5, Block G, Southern Hills Subdivision B and on the west side of  
24 SE Quincy Street being Lots 11, 12, and 13, Block F, Southern Hills Subdivision A  
25 and Lots 2, 3, 4, 5, and 6, Southern Hills Subdivision C will be advanced by the City  
26 Water Utility Fund and a charge will be made for any connection to this main. The  
27 cost of the installation of the water main on Lots 6 through 16, Block G, Southern

28 Hills Subdivision B will be paid by J.P. Investments, Inc., L.L.C. at the time of  
29 installation.

30 Water Main Connection Charge:

31 Any connection to serve Lots 2, 3, 4, and 5, Block G, Southern Hills Subdivision B  
32 and Lots 11, 12, and 13, Block F, Southern Hills Subdivision A and Lots 2, 3, 4, 5,  
33 and 6 Southern Hills Subdivision C, shall be charged a connection charge of \$18.91  
34 per linear foot of frontage plus 6% interest per annum. The connection charge for  
35 any connection is to be charged for a period of fifteen (15) years or until \$18,414.83  
36 plus interest has been recovered.
