6 RESOLUTION OF ADVISABILITY AND AUTHORIZATION NO. 7278

9 A RESOLUTION introduced by Mayor Harry Felker authorizing Street
10 Improvement Project No. 60578-H, located along the west side
11 of Gage Boulevard, south of I-470 at the entrance road for
12 Light of the World Christian Center Church providing concrete
13 pavement, curb and gutter, and sidewalks as more specifically
14 described herein.

16 WHEREAS, the City Council has received a petition, pursuant to K.S.A. 12-6a04,
17 containing the signatures of the owners of 100% of the area in the improvement district
18 hereinafter described; and

19 WHEREAS, seven (7) days have elapsed since the filing of said petition.

20 NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Topeka,
21 Kansas, that it finds Street Improvement Project No. 60578-H, hereinafter described, to be
22 advisable and does hereby authorize and order said improvement to be made in
23 accordance with its findings as follows:

24 A. GENERAL NATURE OF IMPROVEMENT:

26 To Pave:
27

28 Acceleration/deceleration lanes along the west side of Gage Boulevard south
29 of I-470 at the entrance road for Light of the World Christian Center Church
30 providing concrete pavement, curb and gutter, and sidewalks. Included with
31 the project is engineering costs and all other contingencies needed to
32 complete the project.

34 B. PROPOSED IMPROVEMENT DISTRICT:

36 Lot 1, Block "A," Dayspring Subdivision.


