4 RESOLUTION OF ADVISABILITY AND AUTHORIZATION NO. 7352

7 A RESOLUTION introduced by Mayor Harry Felker authorizing Lateral Sanitary  
8 Sewer District No. 40906-01 as more specifically described  
9 herein.

11 WHEREAS, the City Council has received a petition, pursuant to K.S.A. 12-6a04,  
12 containing the signatures of the owners of 100% of the area in the improvement district  
13 hereinafter described; and

14 WHEREAS, seven (7) days have elapsed since the filing of said petition.

15 NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Topeka,  
16 Kansas, that it finds Lateral Sanitary Sewer District No. 40906-01, hereinafter described, to  
17 be advisable and does hereby authorize and order said improvement to be made in  
18 accordance with its findings as follows:

20 A. GENERAL NATURE OF IMPROVEMENT:

22 To provide sanitary sewer service to the following described area with piping,  
23 manholes, engineering, and all other contingencies required for a complete  
24 project.

28 Lots 1 through 8, Block "B," Southboro Subdivision No. 9; Lots 9 through 11,  
29 Block "C," Southboro Subdivision No. 9; Lots 1 through 5, Block "D,"  
30 Southboro Subdivision No. 9; Lot 10, Block "F," Southboro Subdivision No. 9;  
31 Lot 15, Block "M," Southboro Subdivision No. 2, Topeka, Kansas.

On a unit basis for all lots or individual dwelling sites which are included in the described improvement district.

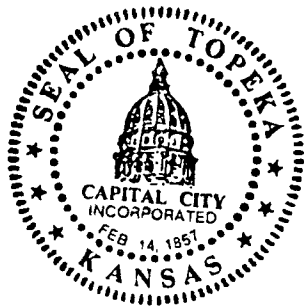
E. APPORTIONMENT OF COSTS:
