11 inadequate or unsafe for travel.

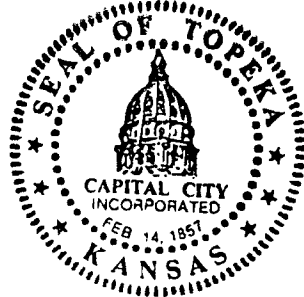
12 BE IT FURTHER RESOLVED by the Council of City of Topeka, Kansas, that owners

42 shall have thirty (30) days from publication of this Resolution to construct,
43 reconstruct, or repair the sidewalk at the owner's expense. If the sidewalk is not
44 constructed, reconstructed, or repaired within thirty (30) days, then the City Engineer shall
45 cause the work to be done by City personnel or under contract. The cost of the
46 construction, reconstruction, or repair of the sidewalk shall be levied against the owner's
47 land.

48 BE IT FURTHER RESOLVED that the City Clerk shall publish the Resolution in the
49 official City newspaper.
