6 A RESOLUTION introduced by Deputy Mayor Duane F. Pomeroy establishing a date for  
7 a public hearing concerning the adoption of a plan pursuant to the  
8 Neighborhood Revitalization Act, K.S.A. 12-17,114 *et seq.*

10 WHEREAS, the City of Topeka, Kansas, may pursuant to K.S.A. 12-17,114 *et seq.*  
11 adopt a plan to assist in the rehabilitation, conservation or redevelopment of any area  
12 within the City of Topeka which meets the conditions provided in said law; and

13 WHEREAS, the City of Topeka is desirous of exercising the authority provided in  
14 K.S.A. 12-17,114 *et seq.* in order to rehabilitate, conserve or redevelop certain designated  
15 areas in the City of Topeka.

16 NOW, THEREFORE, BE IT RESOLVED, by the Council of the City of Topeka,  
17 Kansas, in accordance with K.S.A. 12-17,114 *et seq.* the following notice is hereby given:

18 NOTICE

19 The City Council will consider the adoption of a Neighborhood Revitalization Plan,  
20 pursuant to K.S.A. 12-17,114 *et seq.*, at a public hearing at 7:00 p.m., on November 18,  
21 2003, in the City Council Chambers, 214 E 8th Street, Topeka, Kansas.

22 The proposed Neighborhood Revitalization Plan and a description of the boundaries  
23 of the proposed Neighborhood Revitalization Area are available for inspection during the  
24 hours of 8:00 a.m. to 5:00 p.m. in the office of City Clerk, 215 E 7th Street, Room 166,  
25 Topeka, Kansas.

26 At the conclusion of the hearing, the Council of the City of Topeka will consider  
27 findings necessary for the adoption of the proposed Neighborhood Revitalization Plan and

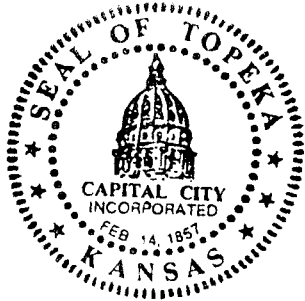
28 the establishment of the proposed Neighborhood Revitalization Area, all as provided for in  
29 K.S.A. 12-17,114 *et seq.*


30 BE IT RESOLVED that the City Clerk shall cause a copy of this Resolution to be  
31 delivered to the other taxing entities within Shawnee County, Kansas.

32 BE IT FURTHER RESOLVED that the City Clerk shall cause this Resolution to be  
33 published in the official City newspaper at least once a week for two (2) consecutive  
34 weeks prior to the hearing.


