3 RESOLUTION OF ADVISABILITY AND AUTHORIZATION NO. 7418

5 A RESOLUTION introduced by Deputy Mayor Duane Pomeroy authorizing
6 Lateral Sanitary Sewer District No. 40915-00 H, located at
7 approximately SE 22nd Terrace and SE Croco Road, as more
8 specifically described herein.
9

10 WHEREAS, the City Council has received a petition, pursuant to K.S.A. 12-6a04,
11 containing the signatures of the owners of 100% of the area in the improvement district
12 hereinafter described; and

13 WHEREAS, seven (7) days have elapsed since the filing of said petition.

14 NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Topeka,
15 Kansas, that it finds the Lateral Sanitary Sewer District No. 40915-00 H, hereinafter
16 described, to be advisable and does hereby authorize and order said improvement to be
17 made in accordance with its findings as follows:

18 A. GENERAL NATURE OF IMPROVEMENT:

20 To construct eight inch sanitary sewer from the east side of SE Croco Road
21 along SE 22nd Terrace to SE Baldwin Road and south along SE Baldwin
22 Road to existing sewer on SE 23rd Street Terrace and eight inch sanitary
23 sewer from SE 22nd Terrace north on SE Aspen Court. Providing piping,
24 manholes and all other contingencies required for a complete project.

26 B. PROPOSED IMPROVEMENT DISTRICT:

28 Lots 1 through 8, Block "A"; Lots 1 through 13, Block "B"; all in Woodglen
29 Subdivision, in the City of Topeka, Kansas.

On a unit basis for all lots or individual dwelling sites which are included in the described improvement district.

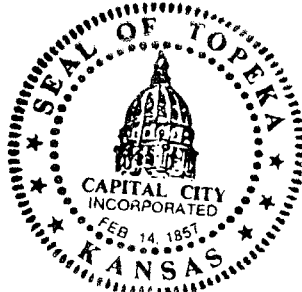
E. APPORTIONMENT OF COSTS:
