4 A RESOLUTION introduced by Mayor James A. McClinton, relating to Waterworks  
5 Project No. 28485 which provides for water line replacement and  
6 authorizing an amendment to the original project budget and  
7 specifically rescinding City of Topeka Resolution No. 7195.

9 BE IT RESOLVED, by the Council of the City of Topeka, Kansas that it finds the  
10 following described public improvement to be necessary and in the public interest and does  
11 hereby authorize Waterworks Project. No. 28485 with an amended project budget as  
12 hereinafter described:

13 A. GENERAL NATURE OF IMPROVEMENT:

14 Waterworks Project No. 28485 (2002/2003 Water Main Replacement) calls for  
15 the replacement of deteriorating water lines at the following locations:

16 Mifflin Road – West Drive to 10<sup>th</sup> Avenue

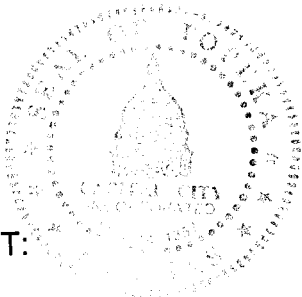
