4 **RESOLUTION OF ADVISABILITY AND AUTHORIZATION NO. 8275**

6 A RESOLUTION introduced by City Manager Norton N. Bonaparte, Jr.,
7 authorizing Sanitary Sewer Improvement Project No. T-
8 401025.00 which provides for sanitary sewer service at 4404
9 NW Halfday Lane, as more specifically described herein.
10

11 WHEREAS, the City Clerk has received a petition, pursuant to K.S.A. 12-6a01, *et*
12 *seq.*, as amended, containing the signatures of the owners of 100% of the area in the
13 improvement district hereinafter described; and

14 WHEREAS, seven (7) days have elapsed since the filing of said petition.

15 NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY of the City of
16 Topeka, Kansas, that it finds Sewer Improvement Project No. T-401025.00, hereinafter
17 described, to be advisable and does hereby authorize and order said improvement to be
18 made in accordance with its findings as follows:

19 A. GENERAL NATURE OF IMPROVEMENT:

21 This project will provide sanitary sewer service to the residence at 4404 NW
22 Halfday Lane. The project will include 330 LF of 8-inch sewer pipe, two (2)
23 standard manholes, trench and backfill, service wye and all other
24 appurtenances needed for a complete project.
