3 **RESOLUTION OF ADVISABILITY AND AUTHORIZATION NO. 8371**

5 A RESOLUTION introduced by Daniel R. Stanley, Acting City Manager, authorizing  
6 Waterline Improvement Project No. T-281036.00 which provides for  
7 water service to Horseshoe Bend Subdivision Nos. 2 and 3 as more  
8 specifically described herein.

10 WHEREAS, the City Clerk has received a petition, pursuant to K.S.A. 12-6a01, *et*  
11 *seq.*, as amended, containing the signatures of the owners of 100% of the area in the  
12 improvement district hereinafter described; and

13 WHEREAS, seven (7) days have elapsed since the filing of said petition.

14 NOW, THEREFORE, BE IT RESOLVED by the Governing Body of the City of  
15 Topeka, Kansas, that it finds Waterline Improvement Project No T-281036.00, hereinafter  
16 described, to be advisable and does hereby authorize and order said improvement to be  
17 made in accordance with its findings as follows:

18 A. GENERAL NATURE OF IMPROVEMENT:

20 This project provides for water service to the following described area  
21 with piping, valves, hydrants, engineering and all other contingencies  
22 required for a complete project.
