Topeka Police Cadet Explorer Post #721 Basic Training Course Information

To become a member of the Topeka Police Cadet Explorer Post #721 prospective Cadets must successfully complete the 10 week basic training course. The Cadet Basic Training Course is a ten (10) week course with training held every Monday night at the Topeka Police Department from 7:00 pm to 9:00 pm.

The Cadet basic training course is designed to educate new Cadets on the basic aspects of law enforcement that are required before attending regular Monday night Cadet training. After completion of the basic training course Cadets will be prepared to join Post #721 in Explorer competitions.

New Cadets will have strict rules to abide by during the Basic Training Course which is taught by experienced officers from the Topeka Police department. Don't be intimidated by the Cadet basic training course. Although challenging, the course prepares new Cadets to join the Cadet Post and offers career education in the field of law enforcement.

If you are interested in law enforcement you will enjoy your experience in the basic training course. The Cadet basic training course involves both classroom and hands on training in:

- Arrest and search procedures
- Building searches
- Traffic stops
- Domestic crisis intervention
- Drill and ceremony

The final week of the basic training course will include taking the written Cadet Uniform Test and completing a series of evaluated law enforcement scenarios.

The only cost to potential Cadets for the Cadet Basic Training Course is a \$12 fee for the Cadet t-shirt that potential Cadets will wear during the basic training course.

REQUIREMENTS:

1. **AGE:** Must be between 14 and 21 years old; must have completed the 8th grade.

2. **PHYSICAL:** Applicants must have a full range of motion and be able to participate in all aspects of Explorer training.

3. **SCHOOL:** If enrolled in high school or college, must maintain a grade point average of 2.0 or higher. If you are not a student, you must show gainful employment.

4. **ARREST RECORD:** All applicants must comply with a background investigation including, but not limited to, a criminal history records check. Any criminal history must not be excessive. There can be no felony adjudications or convictions.

5. **RESIDENCY:** Must be a resident of Shawnee County, Kansas.

6. **LETTER:** Applicant must include a letter of recommendation from each of the following categories: Personal (neighbor, family friend) and Professional (employer, teacher).

7. **INTERVIEW:** Must satisfactorily complete an entry interview with the Lead Cadet Advisor, demonstrating the maturity level to complete the Cadet Basic Training requirements.

8. **BASIC TRAINING:** Upon completion of the 10 week Cadet Basic Training Course you must be able to successfully complete the uniform test with a score of 80% or better.

9. **CADET STATUS:** Upon completion of the Cadet Basic Training Course you will officially be a member of the Topeka Police Cadets.
