Council Minutes – January 6, 2015

COUNCIL CHAMBER, Topeka, Kansas, Tuesday, January 6, 2015. The Councilmembers of the City of Topeka met in regular session at 6:00 P.M., with the following Councilmembers present: Councilmembers Hiller, Brown, Ortiz, De La Isla, Manspeaker, Schwartz, Schmidt and Harmon -8. Mayor Larry E. Wolgast presided -1. Absent: Councilmember Everhart -1.

AFTER THE MEETING was called to order, Councilmember Manspeaker asked for a moment of silent meditation.

THE PLEDGE OF ALLEGIANCE was recited by those present in the chamber.

A PRESENTATION on the City of Topeka e311 online customer service application was provided by Monique Glaudè, Division Director of Community Engagement. She gave a brief overview of application statistics including the number of downloads, users, unique visitors, page views, answers to questions and total requests. She noted as they move forward in 2015 they would continue to find ways to promote the program and help increase users.

A PRESENTATION on the Certificate of Achievement for Excellence in Financial Reporting for Comprehensive Financial Aid Report (CFAR) received by the City of Topeka was provided by Doug Gerber, Administrative and Financial Services Director. He recognized the staff members who assisted with the process and reported the award is the highest form of recognition that is received for excellence in the Government Finance Officers Association (GFOA) allowing Topeka to be a part of an elite group in meeting tough GFOA standards.

Jim Colson, City Manager, referenced the fire incident at 720 S. Kansas Avenue and commended the Topeka Fire, Police, Traffic, Development Services and Public Works

Departments, Mayor Wolgast and Downtown Topeka Inc., for their response and willingness to assist the existing businesses in the area. He recognized the City's new Wellness Coordinator,

Samantha Griffin and commended her for starting a 30-day challenge to create a healthier community and employment base for the City. He commented on discussions regarding

Heartland Park's Request for Proposal process and reported discussions are continuing with two groups; however, these groups do have concerns with the legal aspects of the proposal. wished everyone a great 2015 and looks forward to a new year. She encouraged citizens to

support the Topeka Roadrunners Hockey Team and attend their games.

Councilmember Brown thanked all the first responders for their assistance with the fire at

720 S. Kansas Avenue, as well as, all City employees for their hard work and dedication to the

community in 2014. He noted notifications were sent out to the neighborhoods surrounding the

Southwest Publishing Company property located at 2600 NW Topeka Boulevard regarding an

informational meeting on January 22, 2015 at 6:00 p.m. He stated if anyone needs more

the next few Council meetings as he will be undergoing neck surgery.

Councilmember De La Isla thanked those involved in winterizing three homes in the Hi-

Crest neighborhood, as well as, all the Topeka firefighters who helped extinguish the fire at 720

S. Kansas Avenue on January 2, 2015.
